

# Bear Valley Equestrian Center Mare Motel

## Policy and Agreement

- I. The purpose of this facility is to make available temporary vacation boarding for horses belonging to the Property Owners and renters with amenity privileges. The Equestrian Center Manager will manage this facility.
- II. Reservations must be made in advance and **paid for at the time the horse is brought into the motel.** Checks should be made payable to the Bear Valley Springs Association.
- III. Reservations for use can be for initial periods of 30 days. Use beyond 30 days will be on a space available basis and **will be prepaid if approved.** If animals remain without prior approval and payment, they are subject to Relocation within the Equestrian Facility, at the applicable rate for that location. Reservations will be made and approved by the Equestrian Center Manager.
- IV. Temporary board includes feed, water and cleaning of stalls. Board fee is \$12.00 per day, **payable in advance.**
- V. Nothing in the foregoing will preclude the Equestrian Center Manager from renting stalls on a 24 to 72 hour basis, to individuals not listed in I. above who participate in BVSA approved equestrian events. The Equestrian Center Manager will be responsible to insure that space so authorized is on a space available basis and will not deny exercise of the rights of the Property Owners and renters.
- VI. All users will comply with BVS Association Rules.
