## House Charge Credit Application

### AGREEMENT

Upon approval, the undersigned will establish an open line of credit of **\$500.00** and be allowed to charge purchases at the OAK TREE COUNTRY CLUB, THE MULLIGAN ROOM, THE GOLF COURSE, and THE PRO SHOP. Member house charges can not be used to pay the annual assessment. Other approved users must be age 14 or above.

Bear Valley Springs Association will submit an invoice *within the first fifteen days* of the month for the total amount charged during the previous month. A record of all charges and the actual bills will be kept at the Association Office for inspection. A 15% gratuity will be added for service at the Oak Tree Country Club and Mulligan Room, *unless a specific amount is indicated on the guest check by the patron.*

**All bills are due and payable by the last day of each month.** If payment is not received *by the end of the month*, a **Finance Charge** will be added to the outstanding balance at the rate of **0.75% per month, 9% per annum (minimum \$1.00 charge)**. Should full payment of the account not be received within 60 days, further credit will be denied and all Amenity privileges will be suspended. In the event the account is not paid in full within 90 days after the invoice date, the undersigned hereby authorize Bear Valley Springs Association to bill the full amount then due and owing, including applicable **Finance Charges**, to the undersigned's credit card pursuant to the authorization contained in this Agreement.
