When you receive your election ballot in the mail, send in your ballot by mail to the Inspector of Election, HOA Elections of California, in the return envelope included in your ballot packet. **Ballots must be received at HOA Elections by June 8, 2018.** If you are unable or forget to mail your ballot, please be sure to **attend the annual membership meeting to vote in person.** By returning your ballot you will help ensure we achieve an election quorum. If you choose not to vote, simply shade in the circle that says “ABSTAIN – Quorum Purposes Only” and return your ballot in the prepaid return envelope so that it can be counted toward quorum. **You must sign the prepaid envelope in the upper left hand corner or the ballot is considered invalid and cannot be counted.** Remember, without a quorum, the election must be rescheduled at a cost of approximately \$15,000 to you, the Association Membership.
